State Medical P.G. Seats (M.D / M.S) / Post MBBS DNB / Post MBBS Diploma Allotments-2021
(Mop-up round and Stray vacancy Round)
 (State of Rajasthan)

In continuation to the notification dated 27.12.2021 and subsequent notification(s) including information about NBE Notice dated 12.03.2022 regarding lowering of the qualifying cut-off percentile for NEET-PG 2021 (vide Govt. of India, DGHS letter no.U.12021/21/2022-MEC dated 12.03.2022), the mop-up round (off-line) and stray vacancy round (off-line) allotment procedure for M.D / M.S / Post MBBS DNB / Post MBBS Diploma for Rajasthan State registered candidates, will be carried out off-line as per the schedule given below:

1.	Publishing of provisional vacant seat matrix of mop-up round	26.04.2022
2.	<u>Mop-up round: On-line Application form filling for candidates who have not registered earlier</u> Start date and end date for filling of on-line application form and deposition of required application fee Those who are already registered/have applied need not register/apply again. It is a mandatory step for subsequent process of registration and allotment. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same. Note: A candidate allotted a seat in second round of counseling and has not joined the allotted seat, shall be eligible to participate in mop up round with fresh application and by depositing the registration fee again.	26.04.2022 (from 5.00 pm) to 27.04.2022 by 11.45 pm
3.	Last date for deposition of the application fee, on-line, (including by candidates who have not deposited it earlier)	27.04.2022 by 8.00 pm
4.	Last date for submitting the on-line application form at the website	27.04.2022 by 11.45 pm
5.	On-line deposition of registration amount to participate in mop-up round All registered and eligible candidates willing to participate must deposit, if not deposited earlier, on-line INR 25,000/- (INR 12,500 for SC/ST/OBC/MBC) for allotment in Govt. Medical Colleges and Govt. Societies colleges (Jhalawar) / RUHS Medical College and INR 2,00,000/- (for allotment in Private Medical colleges) by 30.04.2022, 1.00 pm, failing which they will not be considered for allotment. No amount will be accepted at the spot. In Round 1 and Round 2, those candidates who deposited only INR 25,000/- or 12,500/- as the case may be and now wish to opt for private colleges also (along with Govt. colleges) are required to deposit the difference amount of INR 175000 or INR 187500 (as the case may be) on-line by 30.04.2022, 1.00 pm failing which they will not be considered for allotment. 2. The candidates are advised to visit the websites regularly for registration and other relevant information.
3. All registered candidates who wish to participate in off-line mop up round must present themselves personally before the Board on the stipulated date and time.
4. Submission of original documents: All candidates who wish to participate in off-line mop up round must bring all the original documents and undertaking as given in the instruction booklet available at the website.
5. A candidate who has already joined a seat allotted through Rajasthan state counseling / any other state counseling including all India counseling shall not be eligible to participate in mop up round / stray vacancy round.
6. A candidate allotted a seat in mop-up round and has not joined the allotted seat, the registration amount of such a candidate will be forfeited.
