On-line Application form filling Start date and end date for filling of on-line application form and deposition of required application fee Those who have already opted / registered for PCPNDT need not opt / register again. Those who have already registered for NEET PG 2021 in the State and wish to participate for this course need not apply again, but those candidates are required to opt for PCPNDT as 'Yes' under the PCPNDT option available through candidate login. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.	23.05.2022 to 27.05.2022 by 11.45 pm

4.	Publishing of provisional merit list	28.05.2022
5.	Processing of seat allotment by the Board at the spot on the same day, on merit along with submission of all original documents and relevant documents at the venue RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur	30.05.2022 at 8.00 am
6.	Completion of all other formalities, deposition of prescribed fee at the allotted college	Upto 03.06.2022, 5.00 pm

3. **In case during / after round 2 allotment process, adequate number of candidate having eligibility according to additional addendum to instruction booklet are not available for admission then NEET qualified candidates having Rajasthan State domicile certificate will be considered for allotment process, after exhausting the list of candidates having eligibility according to additional addendum to instruction booklet. The NEET qualified candidates having Rajasthan State domicile certificate may opt / apply accordingly.**

All registered candidates who wish to participate in off-line round 2 allotment procedure (for 6 months Ultra-Sound Course under PCPNDT Act) must present themselves personally before the Board on the stipulated date and time and also must bring all the original documents and relevant requisite documents as given in the instruction booklet available at the website.
